Local Funding for Infrastructure Projects

Local Government Infrastructure Surtax: Section 212.055(2), Florida Statutes, authorizes a sales surtax of 0.5 or 1 percent, the proceeds of which must be used to "finance, plan, and construct infrastructure; acquire land for public recreation, conservation, or protection of natural resources; or finance the closure of local government-owned solid waste landfills that have been closed or are required to be closed" by DEP. (...) The surtax must be approved by voters in a countywide referendum after either a majority of the county's governing body passes an ordinance or municipalities representing a majority of the county's residents all adopt uniform resolutions calling for the referendum. The surtax rate is subject to limits enumerated in section 212.055, Florida Statutes, which depend on what other surtaxes are levied in the county and the aggregated surtax rate.

Regional Initiative Valuing Environmental Resources (RIVER) Cooperative Funding Program is available to county governments, municipalities, water supply authorities, and other interested government for projects that enhance or address the District's water supply, water quality, flood protection, and/or natural system responsibilities. Also, funds are available for dairy farms to enhance their wastewater management systems. Department of Agriculture and Consumer Services

Agricultural Best Management Practice Cost-Share Programs: the Department works with multiple partners, including the U.S. Department of Agriculture's Natural Resources Conservation Service, Florida Department of Environmental Protection, water management districts, and soil and water conservation districts, to provide funding to assist producers in implementing Best Management Practices. The Department prioritizes cost-share funding for projects and practices that provide the greatest benefits to water resources.
